Terms and Conditions, Fees

1. Programs

Safari Kid offers unaccompanied programs detailed on the 1st page of this form. We may offer more programs from time to time.

2. Nap time and Lunch Time

The Extended Day and Full Day program include lunch time and possible nap times. Parents need to send lunch with the child in these cases. **Please note that nuts and nut products are not allowed in any snack or lunch at school. Nap times are flexible and timing for naps (if any) needs to be discussed with the school.**

3. Fees and Notice of Withdrawal (Except Refundable Deposits all fees are Non Refundable and Non Transferable)

The following fees and deposits are payable, with due dates as indicated below.

In the event that there is a waiting list, there may be a waiting period before our Administrator will contact you to confirm a place for your child and to notify you of the date of entry for your child and to notify you of the date of entry for your child. The school fee for the term and refundable deposit have to be paid by the date of entry of your child.

Should you wish to withdraw your child from the school, you must notify the school at least six weeks before the end of the term. Notice must be served in writing or by email. We will not entertain verbal notices, in person or on the telephone.

4. Late Pick Up of Children

We understand that emergency situations may arise and we are willing to assist in such cases. However, under normal circumstances, we would appreciate prompt collection of your child every day. Should there be habitual late pick up, the school reserves the right to impose a late pick up fee of Rs. 1000 per hour.

5. School Terms and Holidays

The school year is divided into 3 terms:

Term 1 – 2nd Week of June to 2nd Week of September

Term 2 – 3rd Week of September to 2nd Week of December

Term 3 – 1st Week of January to 2nd Week of April

The school is closed on Saturdays, Sundays and gazetted public holidays. The School Calendar (attached) takes into account all major festive celebrations, term breaks and wherever possible, the major events of Safari Kid.

6. Confidentiality and Privacy

Parents are assured that any information discussed with the Principal and members of staff concerning your child and any family matters will remain confidential.

Safari Kid reserves the right to amend any of the above conditions as directed by our governing board. We look forward to knowing your child.

Safari Kid makes every effort to care for and to cater to your child's needs, adhering closely to Safari Kid's Philosophy. While it is our duty to maintain a safe environment for your child, we realise that accidents can occur. Safari Kid cannot accept liability for any accidents which may occur within our premises. We hope that you will understand the necessity for such a clause and trust that you have read, understand, and agree to abide by all our Terms & Conditions. Thank you.

Indemnity

I/We understand that it is the Philosophy of Safari Kid to make every effort to exercise care and caution while dealing with each child, and would maintain a safe environment for our child. However, we understand that accidents can occur and we thereby agree that Safari Kid, any members of its staff, supervisors, teachers, assistants, directors, shareholders, volunteers, helpers, or owners of the Preschool have no responsibility of whatsoever nature in respect to bodily injury to our child under any circumstance.

To fully and effectively indemnify and keep indemnified Safari Kid and its staff, supervisors, teachers, assistants, directors / shareholders, volunteers, helpers, or owners absolutely harmless against all actions, claims, liabilities, damages, expenses, costs, charges, fees (including medical, judicial, and attorneys' fees) whatsoever, which are in respect of any amounts which Safari Kid may pay, in respect of medical or other expenses arising from such medical treatment mentioned in clauses (1) and (2) above.

I/We agree to indemnify and keep indemnified Safari Kid in respect of any loss or damage to property belonging to or in the custody or control of Safari Kid caused by our child.

I/We understand and agree that Safari Kid's limit of liability (whether in contract, tort, negligence, strict liability in tort or by statute or otherwise) to the parents or students, howsoever incurred, for any and all claims, shall not in aggregate exceed the fees collected by the Preschool from the respective parents.

I/We agree that if by reason of Force Majeure, the Preschool is rendered unable wholly or in part to perform its obligations, then upon notice in writing of such Force Majeure to the Parents as soon as reasonably practicable after the occurrence of the cause relied on, Safari Kid shall be released from such obligations to the extent to which they are affected by the circumstances of Force Majeure and for the period during which those circumstances exist.
